5. APPROVAL OF THE October 8, 2015, MEETING MINUTES (Discussion/For Possible Action.) The members of the Board of Fire Services will approve/make necessary changes to the October 8, 2015 minutes submitted.
6. REVISIONS TO THE NEVADA FIRE SERVICE PROFESSIONAL QUALIFICATIONS MANUAL (Discussion/For Possible Action.) State Fire Marshal Training Bureau Chief Pinkerton will present the following revisions prepared by staff:
 - a. Elimination of certification levels that are less than those in the adopted NFPA Professional Qualifications Standards per the Board discussion and direction given at the October 8, 2015, Board meeting in Reno. Revisions include deletion of Sections 5.26, 5.53 through 5.56, inclusive, and conforming changes to Section 17.

- b. Changes to the Certification Evaluator requirements to reflect changes made by the Division to maintain the security and integrity of the State Fire Marshal Division's testing and certification program. Revisions include adding a new section following 9.4 (new number 9.5), revise Section 9.11 (new number 9.12), revise Section 17.3.4 and revise Section 17.3.5.
- c. Review of the entire Manual by the Board with revisions and updates as the Board deems necessary to continue the professional certification program.

The Board may add, revise, amend or delete sections to the Manual.

7. **ADOPT UPDATED EDITIONS OF NFPA PROFESSIONAL QUALIFICATIONS STANDARDS (Discussion/For Possible Action.)** State Fire Marshal Training Bureau staff is recommending the adoption of the following updated editions to the Nevada Professional Qualification manual. The Board may adopt the noted updated editions of the following NFPA Standards to the Manual:
 - a. NFPA 1002, Standard on Fire Apparatus Driver/Operator Professional Qualifications, 2014 edition.
 - b. NFPA 1003, Standard for Airport Fire Fighter Professional Qualifications, 2015 edition.
 - c. NFPA 1021, Standard for Fire Officer Professional Qualifications, 2014 edition.
 - d. NFPA 1035, Standard for Professional Qualifications for Public Fire and Life Safety Educator, 2015 edition.
 - e. NFPA 1037, Standard for Professional Qualification for Fire Marshal, 2016 edition.
 - f. The adopted edition of NFPA 1041, Standard for Fire Service Instructor Professional Qualifications has now been incorporated in NAC section 477.2835 and the manual is proposed to be revised to so indicate.
 - g. NFPA 1051, Standard for Wildland Fire Fighter Professional Qualifications, 2016 edition.
