*Each year the Board elects one member to be the Chair of the Board.*

*At least one member must be from Clark County, at least one member must be from Washoe County, however, a majority of the voting Board members must not be from any one county.*

*Members serve a term of four years and, except for the State Fire Marshal and the State Forester Firewarden, cannot serve more than two consecutive terms.*
