^{1.} If the proposed cost or bid is more than \$100,000 but less than \$500,000, the fee is \$633.47 for the first \$100,000 plus \$3.22 for each additional \$1,000 or fraction thereof of the proposed cost or bid.

^{2.} If the proposed cost or bid is \$500,000 or more but less than \$1,000,000, the fee is \$1,931.00 for the first \$500,000 plus \$2.84 for each additional \$1,000 or fraction thereof of the proposed cost or bid.

^{3.} If the proposed cost or bid is \$1,000,000 or more, the fee is \$3,337.10 for the first \$1,000,000 plus \$1.65 for each additional \$1,000 or fraction thereof of the proposed cost or bid.

^{4.} If a conference is required for any given project, a fee will be charged at the rate of \$66 per hour or any fraction thereof, for each person from the State Fire Marshal's office required to attend the conference.
