

The Nevada State Fire Marshal Investigation/Enforcement Bureau is responsible to conduct investigations of the fire protection companies and individuals licensed to conduct this work when allegations of violations are reported.

2009 Regulatory Investigation Actions

Case# 090108-0543 – A Sparks based fire extinguisher service registrant was found in violation of NAC 477.315(1)(b) (**Malpractice or incompetence**).

The following actions were taken; Notice of Violation, 12 months probation and the cost of the investigation \$404.21.

Case# 090108-0536 – An out-of-state Type I hood and duct cleaning company was found in violation of NAC 477.300 (**Failure to obtain a license**), NAC 477.770 (**failure to obtain a certificate**) and NAC 477.790 (**Failure to install an approved service tag**).

The following actions were taken; a Letter of Caution was issued to the company.

Case# 090129-1288 – An out-of-state fire extinguisher service company was found in violation of NAC 477.300 (**Failure to obtain a license**)

The following actions were taken; a Letter of Caution was issued to the company.

Case# 090129-0660 – A Las Vegas based fire protection company and registrant were found in violation of NAC 477.310 (**Failure to obtain a license/certificate**)

The following actions were taken; registrant and company owner were issued misdemeanor citations, Notice of violation issued to company, registrant ordered to retest for certification, 12 months probation for company.

Case# 090218-1549 – A Sparks based plumbing company and a fire sprinkler service registrant were found in violation of NAC 477.380 (Failure to obtain a license), NAC 477.425 (Failure to install an approved tag), NAC 477.346 (Not working for a licensed company), NFPA 13 a.6.2.6.2 (Failure to replace painted sprinkler heads), ICC Chapter 1 (administrative)

The following actions were taken; during the investigation the registrant voluntarily surrendered all State Fire Marshal certifications and the company was issued a Letter of Caution. This file was turned over to the State Contractors Board.

Case# 090107-0340 – A Reno based Type I hood and duct cleaning company was found in violation of NAC 477.315 (1)(b) (**Malpractice or incompetence**).

The following actions were taken; Notice of Violation, 12 months probation and the cost of the investigation \$1662.66.

Case# 090226-1053 – A Las Vegas based Type I hood and duct cleaning registrant was found in violation of NAC 477.315 (1)(b) (**Malpractice or incompetence**) and NRS 477.250

The following actions were taken; Notice of Violation, 6 months suspension, must retest, and if successful, 12 months probation, along with the cost of the investigation \$1905.75.

Case# 090402-0671 – An Ely based fire extinguisher service company and registrant were found in violation of NAC 477.425 (**Service tags and Labels**).

The following action was taken; Letter of Caution was issued.

Case# 090427-0493 – A Las Vegas based Type I hood and duct cleaning company and registrant were found in violation of NAC 477.780 (2)(3) (Failure to report deficiencies) and NAC 477.315 (1)(b) (**Malpractice or incompetence**).

The following action was taken; a Notice of Violation, registrant and company were placed in probationary status for 12 months.
