Nevada Administrative Code adoption of the 2012 International Fire Code (IFC).

IFC, Chapter 1

Bail Amount

101.2 General Provisions Against Fire, Compliance Orders and Notices Unlawful Continuation of Fire Hazards

Any Person operating or maintaining any occupancy, premises or vehicle subject to this code, or fail to take immediate action to abate a fire hazard when ordered.

5601.1 All violations pertaining to the manufacturing, possession, storage, handling, sales, and use of explosive, explosive material and small arms ammunition. \$500.00

IFC, Hazardous Materials **Bail Amount**

5001.1 All violations of chapter 50 \$500.00

International Fire Codes 2012 edition: Any other violation not specifically mentioned in the above schedule will have a bail amount of \$100.00.

Nevada Revised Statutes (477.030) License Requirements; application; fee; hearing.

1. A license, issued by the State Fire Marshal, is required for
 - (a) Maintenance, installation or sale of fire extinguishers, fire alarm systems or fire sprinkler systems.
 - (b) Use of explosives in a commercial construction, but not in mining or the control of avalanches.
 - (c) Commercial fireworks displays.
2. Applications for licenses must be made on a form prescribed by the State Fire Marshal.
3. The State Fire Marshal may conduct inspections, examinations or hearings before the issuance of licenses.
4. The State Fire Marshal may charge a reasonable fee, to be fixed by regulations, for the inspection and issuance of licenses.
5. If any person is denied a license by the State Fire Marshal, he is entitled to a hearing, upon request, before a hearing officer.

Nevada Administrative Code (NAC 477.323) (1). A person shall not store a hazardous material in excess of the amount set forth in the International Fire Code, as adopted pursuant to NAC 477.281, unless he has been issued a operational permit by the State Fire Marshal to store that amount. A permit must be renewed annually. \$500.00

Nevada Revised Statutes (477.250): Any person knowingly violates the provisions of this chapter or any of the regulations adopted by the State Fire Marshal's office is guilty of a MISDEMENOR.

Each day on which a violation occurs is a separate offense. \$500.00
