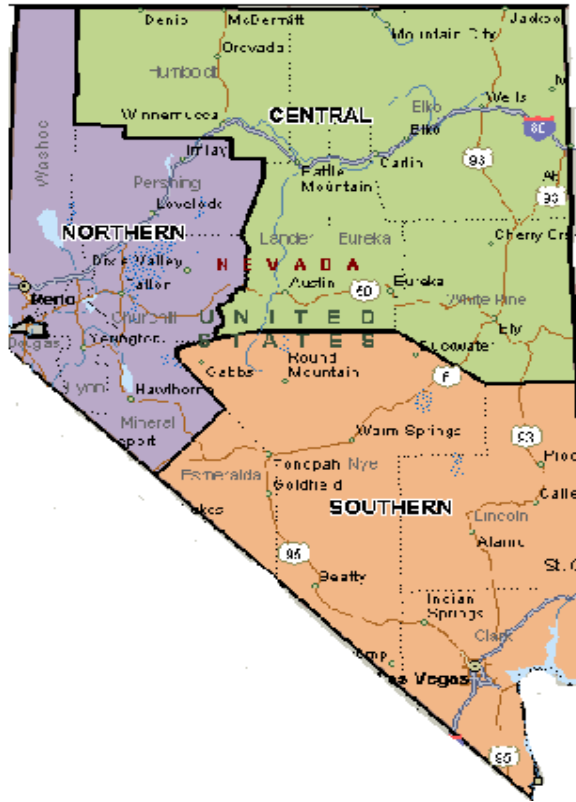

**ELIGIBLE FOR IMMEDIATE  
CALLOUT:**

---

- Fatal Fires
- Fires with Serious Injuries
- Incendiary Fires for which Local Investigators Feel They Have Viable Suspects and Leads
- Major Businesses/ Industries
- Major Apartment Complexes

***NOT* ELIGIBLE FOR  
IMMEDIATE CALLOUT:**

---

- Structure Fires with No Fatalities/ Injuries
- Structure Fires Totally Burned with No Fatalities/Injuries
- Vehicle Fires
- Wildland Fires
- Rubbish Fire

**DIVISION INSPECTORS *WILL*  
INSPECT:**

- State-Owned, Leased, or Public Works Projects
- Health Care Facilities Upon Request of State Health Dept.
- Child Care, Group Care and Family Care Facilities Upon Request of State Health Dept.
- Institutions, Jails, and Prisons as Described in NAC 477
- Schools as Described in NAC 477
- Hazardous Materials Site or Facilities As Described in NAC 477
- Commercial Buildings in Areas of the State as Described in NAC 477 (Only to Areas *Without* Signed Interlocal Agreements)
- Hotel, Motel, and Lodging Facilities as Described in NAC 477

**INSPECTIONS WILL NOT BE  
CONDUCTED WITHOUT  
INVITATION FOR:**

- Federal Sites, Buildings and Facilities
- Building, Facilities and Sites Located on Tribal Reservations
- Hazardous Materials Sites or Facilities and Buildings Located Within Jurisdictions with a Population Exceeding 100,000 or When a Signed, Current Interlocal Agreement is in Place

***NOT* ELIGIBLE FOR  
IMMEDIATE CALLOUT:**

---

- Single-Family Dwellings and Sub-Divisions, Inclusive of Duplexes and Triplexes
- Commercial Businesses Conducted Out of a Single-Family Dwelling
