- Board composition is defined in NRS section 477.073.
- There are ten voting members of the Board. The State Fire Marshal is a nonvoting member and is also the Secretary to the Board. The State Fire Marshal Division provides administrative support to the Board.
- Each year the Board elects one member to be the Chair of the Board.
- At least one member must be from Clark County, at least one member must be from Washoe County, however, a majority of the voting Board members must not be from any one county.
- Members serve a term of four years and, except for the State Fire Marshal and the State Forester Firewarden, cannot serve more than two consecutive terms.
