**About the Class:** The Domestic Terrorism course, sponsored by NTAC and the Department of Public Safety and the Regional Public Safety Training Center provides the necessary enabling tools to proactively develop, collect, retrieve, and disseminate information and intelligence pertaining to terrorism and multi-jurisdictional crime. In addition the information derived from the training will assist in the future identification of domestic extremists engaged in criminal or terrorist activities as illustrated by the following outline/objectives:

1. Understand the definition and scope of United States Domestic Terrorism.
2. Understand the history of home grown Communist and Left-Wing, Anti-government Ideology in the U.S.
3. Understand the motivations and modus operandi of the California-based Symbionese Liberation Army (SLA)
4. Understand the classification and motivations of race driven and religious driven extremism
5. Understand the evolution and role the KKK has played in fomenting racial hatred in the U.S.
6. Understand anti-Semitic/race driven groups & symbols
7. Understand anti-government Ideology
8. Understand the two-tiered Sovereign Citizens Movement track and its foundational beliefs and ideology
9. Recognize and identify Sovereign Citizen tactics often used during traffic stops and enforcement contacts
10. Understand procedures that should be employed by public service employees when interacting with those embracing the Sovereign ideology
11. Recognize the challenges of enforcing and interacting with anti-government protestors at Bundy type events
12. Understand Patriot Movements, including militias and tax protestor groups
13. Recognize special interest groups and their core beliefs, including those involved in the environmental, animal, genetic engineering and abortion rights movement.
